Required Additional Materials

- + If you have reported income (or loss) in line 5, upload Schedule E.
- + If you have reported income (or loss) in line 6, upload Schedule F.
- + If you have reported income (or loss) in any other lines, upload Schedule 1. We will reach out if any additional documentation is needed.
